## PERSONAL GUARANTEE

This is a continuing guarantee and may only be revoked by written notice to Lobster Gram at the address as indicated on page 1. A revocation will not affect any of my **(our)**, obligations under this guaranty with respect to indebtedness incurred pursuant to the guaranty nor will it affect any obligation of any other guarantor signing this guaranty.

If this guarantee is signed by more than one person, suit may be brought against the guarantors, jointly and severally, and against any one or more of them, less than all, without impairing the rights of the creditor, its successors or assigns, against the others of the guarantors; and the creditor may compound with any one of the guarantors for the sum or sums as it may see fit and release any of the guarantors from all further liability to the creditor for the indebtedness without impairing the right of the creditor to demand and collect the balance of the indebtedness from others of the guarantors not so released.
